Battery cabinet tax code

What is a tax code number?

The numbers in your tax code tell your employer or pension provider how much tax-free income you get in that tax year. HMRC works out your individual number based on your tax-free Personal Allowance and income you have not paid tax on (such as untaxed interest or part-time earnings).

What is a tax code & how does it work?

Your tax code is basically a note from HMRC to you and your employer or pension provider that explains how much tax you're due to pay on a monthly basis between April and March (ie over each tax year).

What is an emergency tax code?

This is most likely to be an emergency tax code. These are temporary and usually only appear when you've: started a new job, become an employee after having been self-employed, started receiving company benefits or a state pension. The codes to look out for are: W1,M1 or X. They will normally follow the standard 1257Lcode.

What does a letter in your tax code mean?

Letters in your tax code refer to your situation and how it affects your Personal Allowance. These are emergency tax codes. Tax codes with 'K' at the beginning mean you have income that is not being taxed another way and it's worth more than your tax-free allowance. For most people, this happens when you're:

What is a 1257l tax code?

Your tax code is made up of numbers and letters. 1257L is the tax code currently used for most people who have one job or pension. HMRC will usually contact you to explain how they worked out your individual tax code if your tax code changes.
