Check the case for damage. Check electrolyte level and, if necessary, fill to one-half inch above plates with distilled water. Check the state of charge in the battery. If the battery is below 12.60 volts, the battery must be recharged before it can be tested with a load tester or digital tester. 12.60 volts is considered a fully charged battery.
