

When will a new electricity tariff be applied in Argentina?

Those who do not have a domestic gas supply, for example, may consume more electricity because they use it to cook. In Argentina, modifications to utility tariffs have to be approved at a public hearing. If this new scheme is approved in December, it could be applied in February, Caputo said last week. Otherwise, it will be applied in March.

Who will lead Argentina's energy sector?

The energy sector will be led by consultant Eduardo Rodríguez Chirillo. His team is currently preparing measures related to infrastructure and exports. Argentina is facing a dilemma over the future of its lithium. President Alberto Fernández and his government want to boost the sector's development, and for the state to play a prominent role in both the extraction of the mineral and the development of batteries for electric vehicles (EVs).

Which companies are importing lithium carbonate from Argentina?

Cauchar-Olaroz has contracts with Tesla, Volkswagen and BMW. According to official figures from Argentina's Mining Secretariat, 31,500 tonnes of lithium carbonate were exported last year for US\$134 million, down from US\$184 million in 2019.

How many cars will be taxed in Argentina?

In 1993, a 30-year concession contract was awarded to a private company, to operate the water, and sewerage services in Buenos Aires, Argentina.
