

Did New York fire a battery container?

The immediate damage was quite limited, beyond the battery containers themselves. No injuries were reported from any of the fires, according to the New York State Energy Research and Development Authority ( NYSERDA ), which plays a leading role in the state's grid storage efforts. Nor is the agency aware of any resulting toxic emissions.

What happened to a battery energy storage system in East Hampton?

Just before the end of May, a 5MW/40MWh battery energy storage system (BESS) in East Hampton, on New York's Long Island, experienced an "isolated fire". The system is owned by National Grid and was developed in partnership with a NextEra Energy Resources subsidiary.

What happened at a battery energy storage system in Warwick?

On June 26, 2023, fire alarms were heard at 6:06 PM at two lithium-ion Battery Energy Storage Systems (BESS) facilities in Warwick, NY. A fire broke out in the battery storage facility located on Warwick Valley Central School District land. Two of the newly installed commercial battery storage units ignited and burned.

Are energy storage sites safe in New York?

The state working group will begin immediate inspections of energy storage sites across the state, Hochul said, and "collaborate with first responders and local leaders to identify best practices, address potential risks to public safety, and ensure energy storage sites across New York are safe and effective."

What happened at a battery energy storage system?

The governor's announcement came the day after fire erupted at a battery energy storage system in the Town of Lyme, in upstate Jefferson County on July 27. Hochul cited that fire and others at battery energy storage facilities in the Town of Warwick, in Orange County on June 26 and in the Town of East Hampton in Suffolk on May 31.

Where is a battery storage system deployed in New York?
