As a modern Free Trade Agreement, the EFTA-Kosovo Agreement covers trade in goods, technical barriers to trade (TBT) and sanitary and phytosanitary measures (SPS), trade in services, intellectual property rights, trade facilitation, trade remedies, competition, trade and sustainable development, as well as legal and horizontal provisions.

How many EFTA-Kosovo negotiations were held in 2022?

Negotiations were launched in 2022, with four roundsheld in total. The EFTA-Kosovo FTA covers trade in goods, technical barriers to trade, sanitary and phytosanitary measures, trade in services, intellectual property rights, trade facilitation, trade remedies, competition, trade and sustainable development, and legal and horizontal provisions.

Which countries signed the EFTA-Kosovo free trade agreement?

On 26 September 2024, Member States of the European Free Trade Association - Iceland, Liechtenstein, Norway, and Switzerland- and the Republic of Kosovo concluded a Free Trade Agreement. Further details can be found in a Chapter-by-Chapter Fact Sheet. The EFTA-Kosovo FTA was signed on 22 January 2025 in Davos, Switzerland.

Is Kosovo a free trade country?

Kosovo is a signatory of the Central European Free Trade Agreement(CEFTA) through the United Nations Mission in Kosovo (UNMIK) and has a Stabilization and Association Agreement (SAA) with the European Union that serves, among other things, as a free trade agreement.

Who are Kosovo's trade partners?

According to Kosovo Customs, Kosovo's main trade partners are the EU countries (approximately 44 percent of imports and 30 percent of exports) and its Western Balkans neighbors, with which Kosovo trades tariff-free under the terms of the Central European Free Trade Agreement (CEFTA).

What is the trade between EFTA and Kosovo?

Merchandise trade between the EFTA States and the Republic of Kosovo has grown rapidly since 2008. In 2023,the total trade volume reached EUR 175 million,of which EUR 76 million represented imports from Kosovo and EUR 99 million were exports from the EFTA States.
