Budget 2024: Targeted Electric ... KUALA LUMPUR,October 13 -- The introduction of a targeted electricity subsidy system in Malaysia has proven successful,leading to a significant reduction in subsidies for the highest electricity users without increasing tariffs for the vast majority of consumers.

Why did Malaysia give rm1.935mil in electricity subsidies?

KUALA LUMPUR: The government has allocated RM1.935mil in electricity subsidies for consumers in Peninsular Malaysia for the January to June 2024 period, says the Energy Transition and Water Transformation Ministry. The Ministry said the subsidy is given to minimise the impact of a rise in the global prices of fuel used for power generation.

Is Malaysia exempt from energy subsidies?

Therefore, Malaysia, as one of the top energy subsidized countries, is not exemptfrom this. To increase efficiency in price mechanism and energy consumption, and to decrease the emissions of air pollutants and the burden on the government budget, the Malaysian government plans to reduce energy subsidies.

How will reforming energy subsidies affect Malaysia?

Malaysia is paying a high level of subsidies on the consumption of energy (about 5% of its GDP). Therefore, reforming the energy subsidies, as planned by the government, will have a significant impact on household welfare and energy-intensive sectors, such as the transport sector.

What is a targeted electricity subsidy?

KUALA LUMPUR (Dec 16): The government is implementing a targeted electricity subsidy which will see all domestic users continuing to enjoy the two sen per kWH rebateon their power tariff for the period between Jan 1 and June 30,2023.

Why does Malaysia pay a high level of energy subsidy?

Malaysia pays a high level of subsidy on consumption of energy. The transportation sector in this country is the highest energy consumeramong others.
