What is a battery pack warranty?

In the event energy throughput into (or from) the Battery Pack flows to a 3rd party or whereby such energy is activated or controlled by a 3rd party, the Battery Pack warranty will be limited to 'Fair Usage' levels equal to 10,000 cycles for consumption purposes only at the installed premises.

How long are batteries covered under the warranty?

Batteries supplied with the product are covered under the warranty for six(6) months from date of purchase. Batteries purchased separately are covered under the warranty for six(6) months from the date of purchase.

What is victron energy warranty policy?

1. Victron Energy limited warranty policy Victron Energy warrants its products to be free from defects in workmanship and materials for a period of 5 yearsfrom the date of purchase by the end-user, with a maximum of 66 months from the Victron Energy invoice date.

How long does a battery last?

Exceptions on this are: lead-acid batteries; 2 years from date of purchase by the end-user, with a maximum of 30 months from the Victron Energy invoice date, Lithium batteries; 3 years from date of purchase by the end-user. In addition to this, proof of correct battery usage is required when making a battery warranty claim.

How long will a battery pack last?

We guarantee that each battery pack will retain 70% use of its capacity for the less of either (i) 10MWh of energy throughput per 1kWh of usable capacity (which is equivalent to 5000 full cycles) at 90% DOD (excludes 8.2kWh and 9.5kWh batteries as they have unlimited throughput) (ii) a period of 10 yearsfrom initial installation date.
