What is a non-spillable lead acid battery?

This product is a battery with the GHS Label: Valve Regulated Lead Acid Battery, Non-Spillable. Under normal conditions, this product is sealed and does not leak or vent gasses or hazardous substances. There is no contact with the internal components of the battery or the chemical hazards under normal product use and handling.

What are the legal requirements for lead-acid batteries?

The legal requirements for lead-acid batteries in relation to "end of useful life" are such that they should be disposed in a manner that is appropriate to the current laws and regulations within the state. The storage of the batteries has to be such that it conforms to the safety rules and regulations.

Do flooded lead-acid batteries need ventilation?

Flooded lead-acid batteries must be provided with a dedicated ventilation systemthat exhausts outdoors and prevents circulation of air in other parts of the building. VRLA batteries require comparatively lower ventilation, usually enough to remove heat and gases that might be generated.

How much sulfuric acid is in a non-spillable battery?

The average non-spillable battery contains less than 2 lbs. (0.9 Kg)of sulfuric acid. Section 312 Tier Two reporting is required for non-automotive batteries if sulfuric acid is present in quantities of 500 lbs. or more and /or if lead is present in quantities of 10,000 lbs. or more. This material does not contain any hazardous air pollutants.

What is a lead-acid battery?

Lead-acid battery is a type of secondary batterywhich uses a positive electrode of brown lead oxide (sometimes called lead peroxide), a negative electrode of metallic lead and an electrolyte of sulfuric acid (in either liquid or gel form). The overall cell reaction of a typical lead-acid cell is:
