## Rooftop solar energy control instrument set quota

What does the new quota system mean for rooftop solar systems?

The implementation of the new quota system comes with the removal of the cap on the maximum installed capacity of the Rooftop Solar Systems (which was set at 100% of the connected power of the relevant customers).

Can PLN set a development quota for rooftop solar?

The New Regulation introduces a new obligation of PLN to set a development quota for rooftop solar systems within each of its electricity system in a clustering system.

Do iuptlu holders have to establish quotas for rooftop solar power?

Article 7 (1) of the regulation mandates that IUPTLU holders must establish quotasfor the development of rooftop solar power systems for each electricity grid system.

What is a quota for rooftop solar power plants?

a quota for developing rooftop solar power plants (PLTS) from 2024 to 2028. This determination was made on May 27, 2024, through a Decree of the Director General of Electricity of the Ministry of Energ

Who evaluates the proposed development quota of rooftop solar power systems?

Subsequently, the Director-General of Electricity will evaluate the proposed development quota of rooftop solar power systems involving the Director-General of New and Renewable Energy and Energy Conservation (EBTKE) and may involve relevant ministries or institutions.

How many rooftop solar PV quotas are there in 2024-2028?

K/TL.03/DJL.2/2024. The distribution of rooftop Solar PV quotas is based on the electricity system. The total rooftop solar PV quota in eleven power systems for 2024-2028 is 5,746 MWwith a quota of 901 MW in 2024,1,004 MW in 2025,1,065 MW in 2026,1,183 MW in 2027,and 1,593 MW in 2028.
