

What is Article 6 of the South Sudan Public Procurement & Disposal Act?

Article 6 introduces the South Sudan Public Procurement and Disposal of Assets Authority, a pivotal institution entrusted with the critical role of ensuring that public procurement and asset disposal in South Sudan are conducted with utmost efficiency, equity, and adherence to the law.

What is the South Sudan Public Procurement Act?

The overall goal of the Act is to enhance transparency, reduce corruption, and promote economic development through responsible and efficient public procurement practices in South Sudan.

The UNDP South Sudan Procurement Unit aims to provide quality service and timely, effective and efficient delivery. Apart from locally negotiated contracts and long term agreements, the Country Office has access to contracts that have been signed at the corporate level.

What is the South Sudan national electric sector policy (NESP)?

41. The Southern Sudan National Electric Sector Policy (NESP) has been developed by the Ministry of Housing, Lands, and Public utilities (MHLPU) and was approved by the Council of Ministers on May 9, 2007, before the independence of the Republic of South Sudan.

How much money does South Sudan need to invest in electricity?

The target calls for an extremely ambitious investment program of US\$0.7 billion for the electricity sector as a key driver of growth in South Sudan. None or very little of the ambitious target has been achieved due to lack of funds and lack of capacity to implement the programs. 32.

What are the shortcomings of the electricity sector in Sudan?

A key shortcoming of the sector is that the only legal document for the electricity sector is the Southern Sudan National Electric Sector Policy (NESP), 2007. There is another draft document, namely, Electricity Bill 2013, which has not yet been enacted.
