How do I become a batteries compliance scheme?

How many members does a battery management company have?

The company has 811 members and manages waste portable batteries, industrial batteries, and batteries from electrical vehicles. They have a battery management platform for member producers to request collection, as well as a treatment centre.

Can a member state restrict the use of batteries?

Member States shall not, for reasons relating to sustainability, safety, labelling and information requirements of batteries or management of waste batteries covered by this Regulation, prohibit, restrict or impede the making available on the market or the putting into service of batteries that comply with this Regulation. 2.

Which batteries are covered by the EU batteries regulation?

The regulation applies to all batteries in the EU, regardless of the origin of the battery or its materials, including portable batteries, electric vehicle batteries, and LMT (Light means of transport) batteries. The long awaited Batteries Regulation has been revealed earlier this summer, and went into effect 17 August.

Who is affected by the batteries regulation?

The long awaited Batteries Regulation has been revealed earlier this summer, and went into effect 17 August. The regulation applies to all economic operators of every type of battery placed within the EU market. Economic operators is defined as all manufacturers, producers, importers, and distributors.

What are the regulations governing the use of batteries?

The regulation places certain restrictions on the amount of mercury, cadmium, and lead used in batteries. Economic operators also should consider any restricted substances identified by Annex XVII under the REACH regulation (EC) 1907/2006.

By 2026, batteries will also need to be clearly marked with the "CE" label to demonstrate that it complies with EU health, safety and environmental standards. These labels ...
