

Is an invoice the same as a receipt?

An invoice is not the same as a receipt, which is an acknowledgement of payment. The invoice must include certain information such as: You and the customer also have certain obligations on payment.

Do I need an invoice if I sell a product or service?

If you sell a customer a product or a service, you need to give them an invoice (bill) by law if both you and the customer are registered for VAT (a business to business transaction). An invoice is not the same as a receipt, which is an acknowledgement of payment. The invoice must include certain information such as:

Can a claim be supported by a VAT invoice?

A claim cannot be supported by a VAT invoice which is dated after the dates covered by the claim. This means, in practice, that it may be advisable for employers to arrange for their employees who use, or can use, their cars for business purposes to retain all fuel invoices.

Do I need to keep invoices if my employee buys road fuel?

You need to keep invoices unless your employee buys the road fuel using a fuel card, credit card or debit card provided by you as the employer. You can recover VAT where road fuel is delivered to your employees and paid for by them on your behalf for use in your business.
